This Privacy Policy belongs to Real World Ventures GmbH, with registered office at Belziger Str. 69-71 10823 Berlin Germany, hereinafter referred to as RealWorld.

This Privacy Policy must be read and analyzed, when accessing the website https://www.realworld.fi and its trading platform (http://app.realworld.fi), the provision of your personal data implies knowledge and full acceptance of the conditions contained herein.

In this document, RealWorld explains the personal data that is collected, the purpose of use, the processing, who it is shared with, how long it is kept, as well as the ways to contact RealWorld and exercise your rights.

The holder of personal data explicitly and specifically consents to their processing in accordance with this Privacy Policy and the rules and principles contained in the RealWorld's User Agreement.

Who is responsible for collecting and processing data?

RealWorld is the entity responsible for collecting and processing personal data, and may, within the scope of its activity, use entities (partners) subcontracted by it to pursue the purposes indicated here and with the rules and principles included in the User Agreement of this website and affiliated websites owned and managed by RealWorld.

What constitutes personal data?

Personal data is any information, of any nature and regardless of the respective media, including sound and image, relating to an identified or identifiable person. A person who can be identified directly or indirectly, namely by reference to an identification number or to one or more specific elements of their physical, physiological, psychological, economic, cultural or social identity, is considered identifiable. Personal data is also the set of distinct information that can lead to the identification of a specific person, whether natural or collective.

Why the Privacy Policy?

Because RealWorld is committed to protecting the privacy of its users and clients it has prepared this Privacy Policy with the purpose of demonstrating its commitment and respect for the rules of privacy and protection of personal data.

Because we want to make our users and clients aware of the general rules of privacy and processing of their personal data that we collect and

process in strict respect and compliance with the Personal Data Protection Law and Regulations in force.

The rules set out in this Privacy Policy complement the provisions on the protection and processing of personal data set out in the User Agreement.

Continued use of our websites and digital platform after the publication of changes to the Privacy Policy will imply acceptance thereof. Please read this Privacy Policy carefully because by providing your personal data, you are authorizing collection, use and disclosure in accordance with the rules defined in this Privacy Policy.

What is covered by this Privacy Policy?

This Privacy Policy applies exclusively to the collection and processing of personal data carried out by RealWorld within the scope of its activity. Some functionalities of our platform you can link to other websites that are outside RealWorld. The provision of such links is made in good faith, and RealWorld cannot be held responsible for the collection and processing of personal data carried out on these websites, nor be held responsible for the accuracy, credibility and functionality of websites belonging to third parties.

The provision of links to other websites outside RealWorld does not imply any assumption of responsibility in relation to such websites, and this Privacy Policy is therefore not applicable to them, which is why Users are recommended that, when accessing other websites, they consult the pages that, within these websites, refer to their Privacy Policy.

What personal data is collected and processed?

RealWorld collects and processes, among others, the following personal data:

- Name;
- E-mail address(es);

RealWorld assumes that the data was provided by the data owner or that he or she gave authorization for this purpose and assumes that the data is true and up to date.

Personal data is collected by filling out an online form with personal data, which is requested when registering and transacting on RealWorld websites and platforms; and the user/client, explicitly and specifically, authorizes the processing of their personal data.

How is your data collected?

Personal data may be collected through the following means:

- Website;
- 2. Digital Platform;
- 3. Landing page for marketing purposes;

The data collected is processed and stored electronically and in strict compliance with personal data protection legislation, being stored in a specific database, created for this purpose, by RealWorld or the entities subcontracted by it.

Some personal data collected on the website/platform is mandatory and, in the event of lack or insufficiency of this data, RealWorld may not be able to provide you with the services or information you requested. In each specific case, RealWorld will inform you of the mandatory nature of the provision of the personal data in question.

What is the purpose of the data collected?

Your data is intended to form part of a personal data file that RealWorld may use for the following purposes:

- Uphold regulatory requirements including but not limited to KYC (Know Your Customer), AML (Anti-Money Laundering) and KYT (Know Your Transaction) compliance.
- Sending information about RealWorld's products and services;
- 3. Carrying out client satisfaction inquir ies, market studies, evaluation surveys and statistical analyses;
- 4. Information and marketing of products and services by email, telephone, mobile phone or to your address;
- 5. Sending advertising messages via direct marketing that includes SMS, SEM and MMS and by email;
- 6. Suggestions and Complaints;
- 7. Compliance with other legal or regulatory obligations;
- 8. Deliver goods procured in our platform;
- 9. Customizing user experience.

To pursue the purposes identified above, RealWorld may interconnect the data collected for the purpose of updating and completing such data.

What is the basis for processing your data?

The treatments associated with the purposes of paragraphs 2), 4) and 5) are based on your consent.

The treatments associated with the purposes of paragraphs 8) and 9) are based on the contractual relationship established between you and the company.

The treatments associated with the purposes 3) and 6) (Suggestions and Complaints), 1) and 7) (Compliance with other legal or regulatory obligations) are based on compliance with legal obligations. Furthermore, the processing of personal data by RealWorld may take place for

reasons of legitimate interest related to the execution of services and tasks in relation to its activity as a company, such as the processing of data to improve the quality of service.

Who is your data shared with?

The data collected and held by RealWorld may be transmitted, with respect for the duty of confidentiality and the principle of the purpose that guided its collection, to the following entities:

- 1. Entities of the group in which the RealWorld is inserted in case of regulatory compliance or operational assistance.
- 2. Judicial or administrative authorities, in cases where such transfer is mandatory;
- 3. Subcontractors who will process the data on behalf of RealWorld and in accordance with the purposes determined by it.
- 4. We may share your data or derivatives of your data with independent data controllers and processors, including resellers and distributors, for the purposes of verifying your identity. These third parties provide services to verify or validate the identity of individuals for the purposes of, but not limited to, anti-money laundering regulations, age verification, anti-fraud processes, and pre-employment checks.

"COOKIES"

"Cookies" are small pieces of information that can help identify your browser and that can store information, for example, User settings and preferences.

RealWorld may store cookies on your device to personalize and make browsing as easy as possible, without providing the User with references or personal data

What are your rights?

In accordance with the General Data Protection Regulation, we guarantee you the right to access, update, rectify, delete, transfer and erase your personal data.

We also give you the right to object to the use of the data provided for marketing purposes, for sending informative communications or inclusion in lists or informative services. If you have not demonstrated your right to

object when your data is collected, you can always communicate this or any other right to us later.

- If you wish to exercise your right to delete or erase your personal data or communicate your right to object to the use of the data provided for marketing purposes, for sending informative communications or inclusion in lists or informative services, you can do so via email at dpo@realworld.fi (you must communicate all elements necessary for us to access your request effectively).

How long is your data stored?

The period of time for which data is stored and preserved varies according to the purpose for which the information is processed. Whenever there is no specific legal requirement, data will be stored and retained only for the minimum period necessary for the purposes that motivated its collection or subsequent processing, after which it will be deleted.

Is your data treated securely?

RealWorld is committed to ensuring the protection and security of your data.

To this end, it has adopted several security measures of a technical and organizational nature in order to protect the personal data against its dissemination, loss, misuse, alteration, unauthorized processing or access, as well as against any other form of illicit treatment.

RealWorld requires its subcontractors and partners to adopt security measures equivalent to those it practices.

Notwithstanding the security measures practiced by RealWorld, the user/client must adopt additional security measures. That is to ensure that you use equipment and a browser that is up to date in terms of properly configured security, with an active firewall, antivirus and anti-spyware, and confirm the authenticity of the websites you visit on the Internet, avoiding websites whose reputation you do not trust.

Communications

RealWorld recognizes that it may communicate User data within the scope of merger, acquisition and/or incorporation processes in which it is involved, and this communication is not considered a transfer of data to third parties.

RealWorld may also transmit data to third parties within the scope of investigations, inquiries and judicial and/or administrative proceedings of a similar nature, provided that it is duly ordered to do so by a court order to that effect.

Data Transfer

Data transfers may occur between countries with different data protection regimes.

That includes countries that do not belong to the European Union or the European Economic Area. RealWorld will comply with the law, particularly with regard to the suitability of the destination country in terms of the protection of personal data and the requirements that are applicable to these transfers, and personal data will not be transferred to jurisdictions that do not offer broad guarantees of security and protection.
